





- Discussions on Ukraine, fees and funding, access, gender-based violence, student housing, international students and a "new vision" for education.








Chart 1.7: Changes in public sector net borrowing since our October forecast



# Student finance

- Augar proposed that the max maintenance loan this Sept (England, away from home, outside London) be £10,688 (NMW)
- Instead it will be £9,706 an increase of just 2.3% on this year (an old Q1 23 OBR forecast)
- OBR says inflation will hit 8.7% in Q4
- Also DSA, PG loans all only going up by 2.3%
- Plus £25k family income threshold frozen absolutely
- No entitlement to £150 energy bills rebate
- Nations impacts?




















## Advanced Research and Invention Agency Act 2022

- Passed largely unamended (some government tweaks around devolved consen
- Concerns were around detail of ministerial direction, sunset clause
- Agency was due to start in this session, currently missing a Chair and Chief Exe

## Skills and Post-16 Education Bill

- Introduced 2021 Queen's Speech
- Was originally supposed to operationalise LLE (didn't) and LSIPs (does)
- Includes measures on Essay Mills, OfS absolute benchmarks, OfS defamation
- Currently in "ping-pong" point of difference is on a reprieve for BTECs
- Will almost certainly pass this session

## Higher Education (Freedom of Speech) Bill

- Introduced 2021 Queen's Speech
- Based on lain Mansfield's recommendations for Policy Exchange
- Minor government amendments adds "constituent institutions", removes SUs at "constituent institutions"
- Halfon (et al) amendment pending on university overseas funding reporting
- Has been waiting for report stage since 22 September 2021
- Will **not** now pass this session would require a custom "carry over" motion to continue in next.

## (Likely) Lifelong Learning Bill

- Will be introduced 2022 Queen's Speech
- Will operationalise results of consultation on Lifelong Loan Entitlement (eligibility, scope, infrastructure) and Higher Education reform (MERs, SNCs, foundation years?) as needed
- Likely to be a detailed, technical, Bill (like we assumed SP16E Bill would be)
- Alongside new Schools Bill will likely take up most DfE Bill team capacity

#### Tertiary Education and Research Bill

"General principles" (Stage 1) have been approved by Senedd. Points of difference include:

- Learner and worker representation on governing body of CTER
- Ministerial powers to dissolve HEPs
- Provider autonomy
- Strengthening of safeguarding
- Strengthening of Welsh language duty
- More detail on research (new duty?)
- Update on impact assessments and transparency
