I don't know but it's been said, the OfS dashboard is flashing red

- **Business provision under investigation at 8 (larger) providers**
- **Decisions to inspect draws on outcomes data and NSS responses.**
- **Part of a wider programme of inspections of “poor quality course” (Law is next, we hear)**
- **Focus on blended learning provision post pandemic**
- **... as well as the usual stuff on effective delivery, contact hours, learning resources, and academic s**
- **More detail expected “soon” – we understand at least one provider has formally appealed the decis**
- **Review groups involve OfS staff and academics. No students. No involvement of the DQB.**

Levelling up latest

THE NEW ORTHODOXY

- Oxford-educated Director of the Social Mobility Commission Katharine Birbalsingh couches a message about recognising all forms of achievement and parity of esteem as a national “obsession” with Oxbridge.
- We saw a huge drop of research and data from the Skills and Productivity Board and the Unit for Future Skills. We learn that there are still problems with employer led training, we need better data on skills demands, simply adding skills will not magically level up an area, and that demand for skills in psychology and counselling is predicted to grow sharply.



We should be very worried about anxiety

IT'S BACK TO THE FUTURE?

We are seeing a “rebound” in student satisfaction to pre-pandemic trends (in SAES, and in research from IDP), and the pandemic appears to have had little effect on the activities of recent graduates (in Graduate Outcomes).

But we still need to be concerned about huge increases in anxiety among young people – and there’s some evidence that the actual experience of being a student (and graduate) is a contributing factor).



Uncomfortable truths and open secrets

“Complicit through inaction”

A disturbing report highlights a “boys club” climate of unaccountability, inappropriate behaviour, and toxicity at the Bartlett School of Architecture at UCL.

Perhaps the most worrying aspect was that these issues were well known within the school, provider, and subject community for some considerable time without action being taken.

It is likely that similar stories will emerge from other parts of the sector.





Sunset on the horizon?

- The sector still awaits news of the UK's attempt to affiliate with EU-funded research programmes.
- The issue is bound up in other Withdrawal Agreement arguments – we are promised a decision later this year.
- Meanwhile UK HE is missing out on involvement in international



ASKING STAFF


Key findings:

- Need a wide working definition of inclusion
- Progress is being made on course design but more to do
- Not always a staff priority given competing demands
- The quality of a student's relationship with academics teaching on the course

Renters reform

- Decent homes, ombuds, pets

Major change to rental Ts and Cs

- To facilitate abolition of "no fault" evictions, all tenancies (HMOs) will be rolling "periodic" tenancies and fixed term tenancies abolished
- All tenants will be able to give two months notice
- Rent early? But they can cancel, and the room isn't free
- International students? Upfront rent as an alt to deposits and guarantor won't work any more
- When will students sign? Interaction with academic year pressures
- Exempt students? But why should students not have the right to stay and the two month cancellation right?
- 12 month contracts die – a student wanting to leave in June will give notice in April – implications on rent costs (and who's then left around)

Free speech bill

As a reminder...

- Toughening of existing duty – becomes something to promote and more than external speakers and room bookings
- New DoAFaFoS on the OfS appointed by SoS
- Will operate an ombuds scheme (relationship with OIAHE)
- Freedom of speech within the law BUT reasonably practicable wording and balancing with other duties
- Students' unions directly regulated UNLESS an SU of an Oxbridge College
- New legal tort if a person is impacted by a failure re the duty

Free speech bill

- Copy and paste emphatically rejected in the Senedd yesterday Report stage
- Foreign funding (free speech or security?)
- Security costs (will this work?)
- Academic freedom definition addressed (expertise...)
- NDA ban defeated (MD very strong on OfS regulation and what it will achieve)
- Harassment and a free speech defence amendment defeated (existing balance left intact, OfS will issue guidance)
- Labour amendments on political neutrality of the DoAFaFoS and a sunset clause both obviously defeated
